Oksana Vasylchenko, who informed the members of the Advisory Group that Hanna Suchocka has submitted a self-recusal application regarding participation in the consideration of the request to the Venice Commission, because she is the Honorary President of the European Commission for Democracy through Law, and that the members of the Advisory Group had the opportunity to review the application before the session. Since there were no additional questions regarding this application, Oksana Vasylchenko proposed to vote for approval of the application for self-recusal of Hanna Suchocka, a member of the Advisory Group of Experts, from participation in the consideration of the request to the Venice Commission.

2. 2. On the request to the European Commission for Democracy through Law (Venice Commission).

Heard:

Oksana Vasylchenko, who reported that at the end of October, the Parliament registered draft laws on amendments to the Law of Ukraine "On the Constitutional Court of Ukraine" and "On the Rules of Procedure of the Verkhovna Rada of Ukraine" in the part concerning the activities of the Advisory Group of Experts. In view of this, the Advisory Group of Experts is considering the possibility of appealing to the Venice Commission for an assessment of these draft laws and the changes proposed by the members of parliament, since the new transparent procedure for selecting and evaluating candidates for the positions of judges of the Constitutional Court with



the participation of the Advisory Group of Experts is an important component of the constitutional reform.
